## 1. Call to Order

## 2. Staffing Action: Director of Wildlife Management

Mr. Noble reported that the reference checks on the lead candidate for the Director of Wildlife Management position, Dan Pike, were very positive. Work has started on drafting a secondment agreement with DFO. The one outstanding issue is Mr. Pike's insistence to be governed by DFO overtime provisions, which differ from those being followed by the Board. It was agreed to defer to Mr. Pike's wishes on this matter, but to advise him that a pre-authorization system for overtime might be implemented if the matter becomes a problem in the office. It was noted that the Board will need to make provision for Mr. Pike's annual increment (he has one step remaining), but the Board will not be responsible to match the pay associated with any promotions or re-assignments that may be implemented for Mr. Pike by DFO. The Executive Director was charged to conclude negotiations and the development of necessary documentation.

### 3. Staffing Action: Director of Finance and Administration

Mr. Noble advised that the Director of Finance and Administration position had been advertised, including in the Globe and Mail and Nunatsiaq News. The closing date for applications is July 28. Applications will be available for screening at the Board's next regular Meeting.

### 4. Walrus Sport-Hunting Proposal: Igloolik

Members discussed arrangements yet required to accommodate Igloolik's proposed walrus sport hunt. It was agreed to devote another Conference Call to this matter this afternoon, with Robert Moshenko (DFO) and Michael d'Eça (NWMB legal advisor) to participate.
