

Community-based Monitoring Network Quarterly Update & Part-time Employment Opportunity: Data Clerk in Taloyoak, Nunavut

Project Overview:

The Community-based Monitoring Network was first launched in 2012 by the Nunavut Wildlife Management Board (NWMB). The Project brings together respected Nunavummiut harvesters to share their knowledge and observations about wildlife. Participants are trained to use specialized hand-held computers to record wildlife harvests and observations while out on the land. When harvesters return to the community, trained Data Clerks transfer the information into a database. Information recorded by the harvesters is used to improve local, regional, and territorial wildlife management practices in Nunavut.

Project Update:

The Community-based Monitoring Network wrapped up in Clyde River in September 2018, following three very successful years of data collection. The contributions of Clyde River harvesters to the project is invaluable. Thank you!

The Community-based Monitoring Network is going strong in Kugaaruk, with participants consistently uploading high quality data about their wildlife harvesting patterns and observations while they are on the land. A big thank you to Kugaarumiut involved with this work.

The project launched in Baker Lake in April 2018. The Project Team followed up with a community visit in August 2018. We have trained an impressive group of 80 Baker Lake harvesters! The NWMB looks forward to working with you.

Part-time Employment Opportunity:

The NWMB is accepting applications for a part-time data clerk position in **Taloyoak.** The data clerk will join the project team for the Community-based Monitoring Network beginning December 1, 2018.

The Data Clerk works with local participating harvesters, downloads the data from the hand-held computers, and manages it in a secure and confidential environment. The Data Clerk acts as the liaison between the local Hunters and Trappers Organization and the Project Team. The successful candidate will receive training and support from other members of the team.

Applicants should meet the following requirements:

- be resident in the community of Taloyoak;
- be fluent in English and Inuktitut;
- have an interest in wildlife, harvesting, land skills, or co-management initiatives;
- have basic internet and computer skills; and
- experience with handheld computers, tablets, or technical devices will be considered an asset;
