### **Explanation of Variances:**

- (1) Fuel purchase: Observed variance due to fuel prices and associated shipping costs that were greater than initially anticipated
- (2) Fuel Caching: Observed variance due to still outstanding invoices from PCSP.
- (3) Fuel drum loading/moving: Observed variance due to still outstanding invoices.
- (4) Field equipment: still expecting invoices until FY end
- (5) Cabin/Base camp set-up: Observed variance resulted from both camps being in better condition than previously assumed since we did not have an opportunity to inspect all camps prior to the start of the field season, and we were efficient in making the camps work with little expenditures.
- (6) Survey Helicopter Observed variance due to outstanding invoices within this FY
- (7) Travel, Food & Accommodation: Observed variance resulted from efficient use of funds and flight schedules; improved weather kept us in community for less period of time.

- (8) HTO field assistants: Observed variance due to weather constraints and delays which resulted in having fewer HTO assistants in the field (also for shorter time intervals) with us as initially forecast; in addition many planned HTO assistants were engaged in another project and cancelled their plans with us short-notice.
- (9) Genetic analyses: Observed variance results from not having all samples genetically analysed yet final invoice is expected before the FY-end.
- 10) Data analyses: variance observed because this may get done in-house, and the money will be used for the expenditures still outstanding for genetics and field equipment (more samples than expected will increase the genetics costs; more camp and field gear needed than expected).
- 11) Shipping: Observed variance is due to the taken advantage of a NRCAN charter flight and the offer to have all our necessary gear and food delivered instead of using commercial airlines.
- 12) Fuel-cache clean up: Observed variance due to the fact that to this point local cache clean-up activity has not taken place yet.
