#### **Explanation of Variances:**

- (1) Helicopter Observed variance due to difference between projected hourly rate and actual rate obtained from vendor. In addition, flying hours were increased from 262 to 320 to ensure adequate survey coverage of the study population.
- (2) Twin Otter The observed variance was due to a difference in the hourly charter rate (projected at the time of proposal submission to NWMB) versus the rate eventually set by the vendor (PCSP). In addition, the number of hours required for caching was less than anticipated.
- (3) Fuel Variance reflects price variation in the market
- (4) HTO survey observers HTO observers participated in the survey while operations were based in communities. However, number of person days were less than originally anticipated due to less time being spent in communities and availability of HTO designated observers.
