## MINUTES: CONFERENCE CALL No. 57

### 1. Opening by Chairperson

Ben Kovic opened the Conference Call at 1:00 p.m. Iqaluit time. Ben expressed the intention of trying to make the call as short as possible, with a two-hour time limit. He thanked all the Members for taking the time to participate.

### 2. Agenda for Conference Call

The Board approved (**Resolution 2001- 041**) the Agenda for the Conference Call as presented.

### 3. Pre-Hearing Consultation Summary: Community-Based Management

Michael d'Eça reviewed his draft paper titled "Pre-Hearing Consultation Summary of the NWMB Concerning Community-Based Management."

Attached to and forming part of the Consultation Summary is the NWMB Discussion Paper concerning Improvements to Community-Based Management. It is proposed in the Discussion Paper that the survival and expansion of community-based management (CBM) will depend upon the achievement of five main objectives:

- (a) Harvests must at all times remain within sustainable limits;
- (b) Reporting of struck and lost animals must be complete and accurate;
- (c) The number of struck and lost animals must be reduced;
- (d) Up-to-date population estimates, based upon both science and *Inuit Qaujimajatuqangit*, must be assembled; and
- (e) The NWMB, DFO and NTI must more effectively contribute to the effort to make community-based management a success.

Michael suggested that the fundamental issue is what number of narwhal in each community participating in the CBM system would constitute a sustainable harvest.

Michelle Wheatley advised that at the recent meeting of the Scientific Working Group of the Canada-Greenland Joint Commission on Narwhal and Beluga in Greenland, it was noted that there may be more than one stock, perhaps even nine to fourteen stocks or aggregations of narwhal in Baffin Bay. It does not appear that there is much sharing of these animals, as originally thought, other than between Grise Fiord and Greenland. Greenland is planning surveys this coming fall, and the Department of Fisheries and Oceans is planning surveys for the summer of 2002 onward. The basic advice from the Scientific Working Group was that there are few concerns at present but that we should proceed carefully as some stocks may be over-harvested.

Kevin McCormick suggested that proper stock delineation must precede efforts to estimate the size of the stock.

Gordon Koshinsky suggested that it may not be the most appropriate or cost-effective to focus on population levels exclusively. Stock delineation and productivity may be more important factors, and the whole issue should be examined in the context of risk analysis.

There was discussion and agreement that the NWMB Chairperson should contact the communities participating in CBM, and stress the importance of reducing struck and lost rates.

Kevin McCormick stressed that the Board should not make blanket financial commitments without knowing the costs of such commitments.

The Board noted that there was some urgency to deal with the Broughton Island hunt closure, and accordingly decided that this portion of the overall review should be separated and dealt with independently. It was also decided to defer the pre-hearing report for further discussion at the next NWMB meeting, especially with reference to the Board's recommendations.

#### **4. Community-Based Management for Narwhal at Kugaaruk and Arctic Bay**

**Kugaaruk:** The Board discussed Kugaaruk's proposed Hunting Rules for the 2001 season. The Board decided **(Resolution 2001- 042)** to approve Kugaaruk's plan, and also to approve a limit of 40 narwhals for the community for 2001.

**Arctic Bay:** The Board discussed Arctic Bay's proposed Hunting Rules for the 2001 season. The Board decided **(Resolution 2001- 043)** to approve Arctic Bay's plan. The Board also approved a limit of 150 narwhals for the community for the 2001 season, this on condition that the HTO re-instate its rule as initially drafted pertaining to narwhal conservation.

#### **5. Request for Narwhal Quota Increases: Pangnirtung and Clyde River**

The Board discussed requests from Pangnirtung and Clyde River for narwhal quota increases for 2001. The Board decided **(Resolution 2001- 044)** not to approve any increases on the grounds that there is not enough new information about the stock. Meeka Mike expressed dissatisfaction with this decision on the basis of recent studies conducted in Cumberland Sound, noting also that the communities have been requesting increases for the past 20 years.

#### **6. Foxe Basin (Igloolik) Greenland Cod Test Fishery**

The Board decided **(Resolution 2001-045)** to approve the request from Samson Kangok for approval of a test fishery for Greenland cod in the Igloolik area on the condition that the licence will be issued to the Igloolik HTO.

#### **7. Pangnirtung Arctic Charr and Greenland Cod Test Fishery**

The Board decided **(Resolution 2001-046)** to approve a request from Levi Evic of Pangnirtung to conduct a test fishery for Arctic charr and Greenland cod in the Cumberland Sound area on the condition that the licence will be issued to the Pangnirtung HTO.
