Dear Colleagues:

Re: Written hearing of the Nunavut Wildlife Management Board to Consider the Listing of Red Knot rufa as an “Endangered Species”, and Red Knot islandica as a “Species of Special Concern” in the Nunavut Settlement Area

The Nunavut Wildlife Management Board (NWMB or Board) has scheduled a written hearing to consider the proposed legal listing, pursuant to the federal *Species at Risk Act* (SARA), of two sub-species of Red Knot, an Arctic breeding shorebird. Red Knot rufa is proposed to be listed as an “*endangered species*” in the Nunavut Settlement Area (NSA), and Red Knot islandica is proposed to be listed as a “*species of special concern*” in the NSA.

If a wildlife species is listed as endangered, it means that the species is facing imminent extirpation or extinction. If a wildlife species is listed as special concern, it means that the species may become threatened or endangered in the future because of a combination of biological characteristics and identified threats.

A written hearing is one in which all submissions are filed in writing, and the hearing does not have an oral component. If you have an objection in this case to the NWMB holding a written hearing only, please respond in writing to this letter by no later than 5:00 p.m. (Iqaluit time) on November 20th 2009, providing the reason or reasons for your position. **The NWMB will not consider any objection received after the November 20th deadline.**

Attached to this letter are copies of the Government of Canada's Department of Environment-Canadian Wildlife Service (CWS) *Proposal for NWMB Decision* concerning Red Knot rufa and *Proposal for NWMB Decision* concerning Red Knot islandica (CWS Proposals), filed recently with the Board. The NWMB is expecting to soon receive a comprehensive set of documents from CWS, comprising the best available information to date concerning the proposed listing of Red Knot rufa as an endangered species, and Red Knot islandica as a species of special concern. Plans are currently underway to place all of those documents on the NWMB's website (www.nwmb.com) by no later than November 13th 2009. Through this letter, the NWMB is inviting your department/organization to file written submissions responding to either or both of the CWS Proposals and any other relevant documents filed with the Board – duly translated into English and Inuktitut or Inuinnaqtun, as the case may be – by no later than 5:00 p.m. (Iqaluit time) on January 8th 2010. The requirement for translation at the time of filing is mandatory.

Unless persuasive written and translated reasons are provided to the Board for late filing, the NWMB will not consider materials for this hearing that are not filed on time.

Shortly after the deadline for delivery of the written submissions, the NWMB will consider all of the relevant evidence and arguments filed for each sub-species, and will make separate decisions whether or not to approve the listing of Red Knot rufa as an endangered species, and whether or not to approve the listing of Red Knot islandica as a species of special concern.


Submissions may be filed with the Board in person, by courier or by mail. They should be clearly marked as pertaining to the NWMB Hearing for Red Knot. Delivery of the submissions may also be made through fax or electronic transmission, but only if your department/organization confirms by phone with the NWMB – by no later than 5:00 p.m. (Iqaluit time) on January 8th 2010 – that a complete and legible copy of the transmission has

been received by the Board. Documents are deemed to have been filed on the actual day of receipt by the NWMB.

Please keep in mind that the more thorough, reliable and persuasive supporting evidence and justifications are for your submissions, the more weight they will be given by the NWMB in the *Nunavut Land Claims Agreement* decision-making process.




