### 1. Opening by A/Chairperson

Harry Flaherty convened the meeting at 10:30 a.m. and welcomed members.

### 2. Review/Approval of Agenda

The Board decided (**Resolution 2005-008**) to approve the agenda with three changes;

### 3. Polar Bear, Grizzly Bear and Wolverine

The Board discussed the DOE representative's presence when species at risk are discussed and decisions are taken. It was felt it would be best if the DOE nominee would step aside when these issues are dealt with, to avoid conflict of interest.

The Board directed the Board's Legal Advisor to draft a letter to the Minister of Environment regarding these 3 species. The Board decided (**Resolution 2005-009**) to support the initiative for consultation for grizzly bear and wolverine, but not for polar bear. Polar bear should be returned to COSEWIC for reassessment of recent IQ information and further consultations with the communities.

#### **4. Polar Bear NQL Letter to NTI**

The NWMB Legal Advisor informed the Board that the original letter was sent to the Chief Operating Officer in December 2004. The letter claims that NWMB decision does not follow the NLCA and they did not have enough time to consult. The Legal Advisor went through the letter and explained the issues, then reviewed a draft response letter that essentially states that the Board's decision should stand as presented. The Board decided (**Resolution 2005-010**) to approve sending the letter to NTI as drafted.

#### **6. Amarok Polar Bear IQ Project**

The COO provided a briefing on the Amarok HTO's request for funding assistance to conduct a Polar Bear IQ Project. The Board decided (**Resolution 2005-011**) to approved funding for \$5000 for this IQ project conditional on the HTO finding other funding partners.
