

A secondary cause for the delay was extensive discussions between the Government of Nunavut, Department of Environment, Nunavut Tunngavik and the Nunavut Wildlife Management Board with respect to the proposed methodologies and the utility of the expected results. It is expected that these funds will be expended during the 2014-2015 fiscal year.
