Horned Grebe ᑲᑦᑲᑦ ᑲᑦᑲᑦ

- Small waterbird

- Short, straight bill with a pale tip

- Breeding plumage:

 - Patch of bright buff feathers behind the eye (“horns”) ᑲᑦᑲᑦ ᑲᑦᑲᑦ ᑲᑦᑲᑦ ᑲᑦᑲᑦ ᑲᑦᑲᑦ ᑲᑦᑲᑦ ᑲᑦᑲᑦ ᑲᑦᑲᑦ

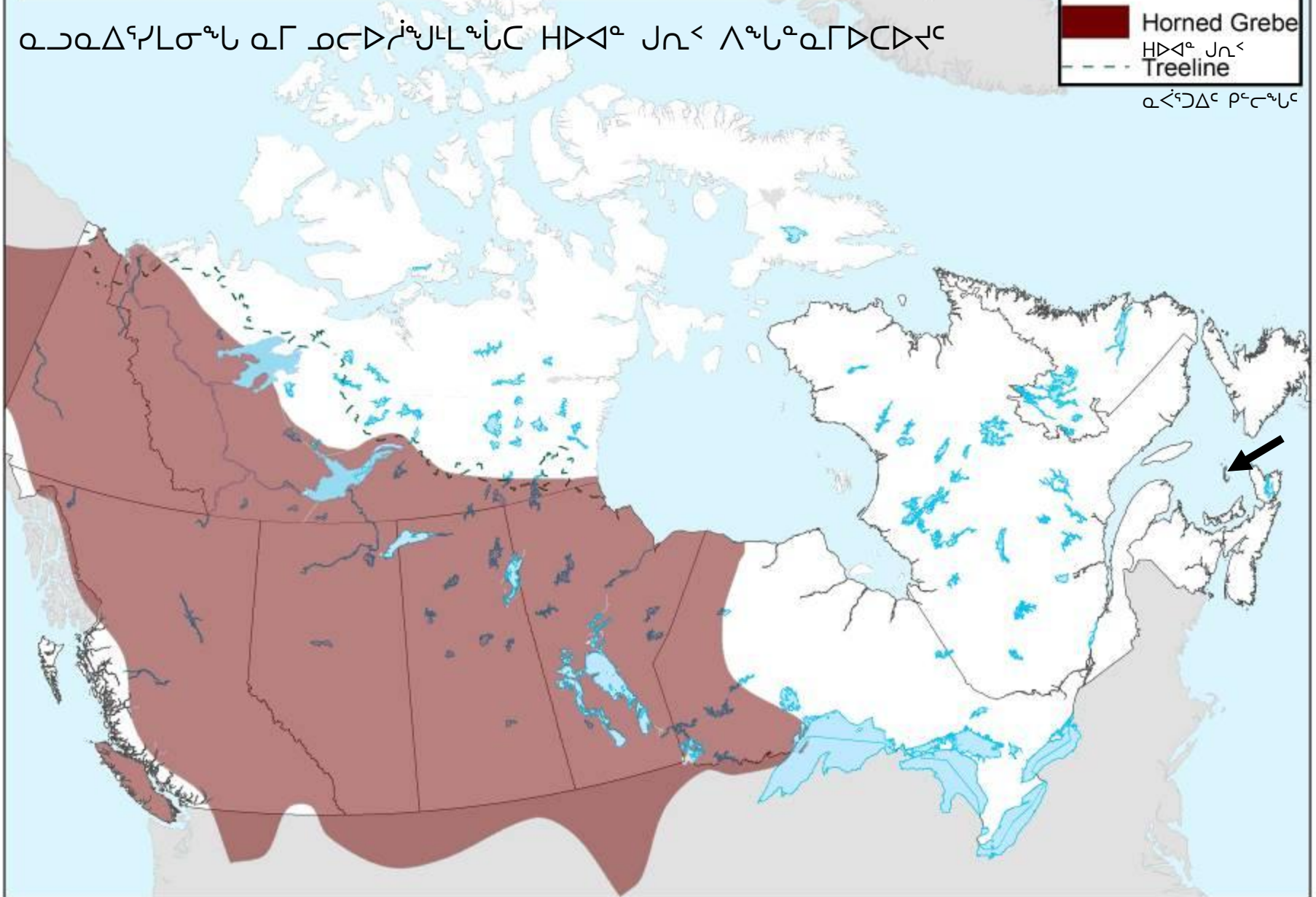

Annual Cycle ᐱᐃᑦᑭᑭᑦᑭᑦ ᐱᑦᑭᑦᑭᑦᑭᑦ

- Arrive in NWT in mid-May or early June
ᑭᑦᑭᑦᑭᑦᑭᑦ ᑭᑦᑭᑦᑭᑦᑭᑦ ᑭᑦᑭᑦᑭᑦᑭᑦ ᑭᑦᑭᑦᑭᑦᑭᑦ ᑭᑦᑭᑦᑭᑦᑭᑦ
- Lay 3 to 8 eggs, which incubate for 20 days

- Leave the NWT between mid-July and early September.
