Re: Nunatsiavut Government (NG) submission to the NWMB—NMRWB joint written public hearing to consider the 2020-21 total allowable catch levels for Northern and Striped shrimp

I write to you today to express our concerns with the current fishery and quota allocation within the Eastern Assessment Zone.

In 2013 the Government of Canada implemented a boundary change to the Eastern Assessment Zone (EAZ). The 2013 decision to extend the Davis Strait West Management unit of the EAZ into Shrimp Fishing Area (SFA) 4 brings the EAZ directly within and adjacent to the Labrador Inuit Marine Zone. Waters adjacent to the zone means those Canadian fisheries waters within the portions of Northwest Atlantic Fisheries Organization Divisions 2G, 2H and 2J adjoining and lying due eastward of the Zone. The EAZ now extends into NAFO Division 2G.

Since the ratification of the Labrador Inuit Land Claim Agreement in 2005, the Nunatsiavut Government has been requesting Canada for access to shrimp in keeping with the intent of our Land Claim Agreement. NG access in both SFA 4 and 5 has not met a minimum of 11% and we continue to lobby for adequate quota in these management areas.


The NG currently have no access to northern or striped shrimp in the EAZ, even though the management area is now within and adjacent to Nunatsiavut. Both Nunavut and Nunavik fish northern shrimp in SFA 4 and 5. We believe it only fair in recognition of this, that Nunavut and Nunavik consider the Nunatsiavut Government request for access to northern shrimp in the EAZ.

The NG support increasing the TAC for P.Borealis in the EAZ by 20% (+1,722T) and recommend the NG receive 75% of the increased quota in the EAZ. This is justifiable in recognition of the NG currently having no access to northern shrimp in this management zone that is both within and adjacent to Nunatsiavut.

The NG supports maintaining the existing TAC for P.Montaguui in the EAZ at 840T.

Members of the boards, the Nunatsiavut Government ratified a Land Claim Agreement with Canada in 2005, with the understanding that the Agreement would offer meaningful benefit for Labrador Inuit in waters within and adjacent to Nunatsiavut. The rights and interest of Labrador Inuit should not be marginalized and we look forward to a favorable decision by the boards.


