1. ORIGINAL PROJECT BUDGET AND CONTRIBUTIONS - 2010

Canadian Wildlife Service (confirmed cash) \$6,000 support.

Canadian Wildlife Service (confirmed 'in kind') \$5,000 'in kind' for use of existing equipment, and \$18,000 in salary-related contributions.

Kangiqliniq HTO and the Issatik HTO (in kind) The Rankin Inlet HTO and the Whale Cove HTO will provide logistic services in selecting guides, and selecting suitable elders or hunters for IQ interviews.

Nunavut Wildlife Research Trust \$10,600 support.

Discrepancies between proposed and actual budget:

There were minor discrepancies in the project budget between our planned and actual contributions and expenditures. I explain the key differences as follows:

1. In Whale Cove, thirteen local residents were interviewed instead of the 10 that was in the original project proposal. The total interview costs at Whale Cove then was \$780.00 (\$60 x 13 interviews) instead of \$600.00 for 10 interviews.
