Re: Follow-up of the Nunavut Wildlife Management Board pre-hearing teleconference concerning the establishment of a management unit and total allowable harvest for Foxe Basin walrus

On October 14th 2014, the Nunavut Wildlife Management Board (NWMB or Board) held a pre-hearing teleconference concerning the establishment of a management unit and total allowable harvest for Foxe Basin walrus. Representatives from the Hall Beach and Igloolik Hunters and Trappers Organizations, the Qikiqtaaluk Wildlife Board, Nunavut Inuit Wildlife Secretariat, Nunavut Tunngavik Incorporated, and Fisheries and Canada joined the NWMB in discussing the upcoming hearing.

The majority of the discussion was in regards to the date, time and location of the inperson hearing, as well as associated submission deadlines. Outlined below summary of the discussion:

- 1. An in-person public hearing is planned to take place in Igloolik on January 14th and 15th, 2015
- 2. The deadline for written submissions to the hearing will be December 17th, 2014
- 3. The NWMB will cover the cost of attendance for two Hunters and Trappers Organization representatives and two qaujimaniliit from each community; including the cost of travel and accommodation for representatives from Hall Beach.
- 4. The hearing will be open to the public and there will be several opportunities for members of the public to speak and ask questions.
- 5. Inuit Qaujimajatuqangit submissions from qaujimaniliit are welcome and encouraged.
