Collect and analyse existing information relating to the eco-systemic and socio-economic health of Nunavut.

Provide cyclical snapshots of the state of the territory's ecosystemic and socio-economic health.

Contribute to regulatory improvement by providing access to credible Nunavut environmental monitoring information.

Provide quality data for use in decision-making processes, enabling Nunavummiut to participate in resource development and management.

Provide a forum for community outreach and peer networking opportunities.

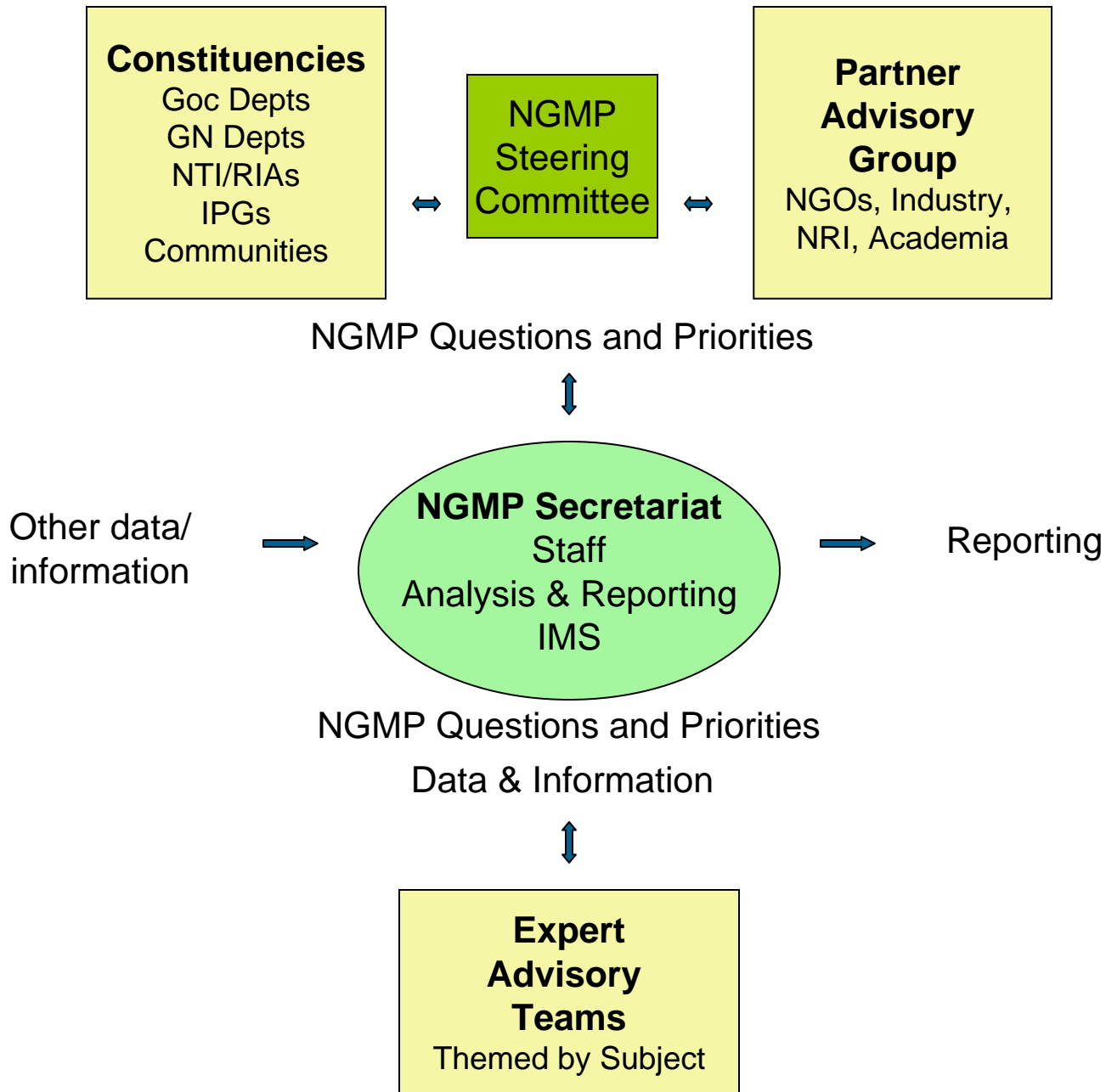
NGMP is:
