**Issue:** Advisory Committee for Cooperation on Wildlife Management Meeting, January 24<sup>th</sup> and 25<sup>th</sup>, 2013 in Yellowknife

**Background:** The wildlife co-management boards have met informally over recent years to share information and coordinate their activities with respect to shared resources. This working relationship was formalized through a "Memorandum of Understanding: Cooperation on Wildlife Management" which was completed in 2008. The Advisory Committee for Cooperation on Wildlife Management is intended to exchange information, help develop cooperation and consensus and make recommendations regarding wildlife and wildlife habitat issues that cross boundaries or land claim agreements and treaty areas.

The Advisory Committee for Cooperation on Wildlife Management determined that a Bluenose caribou herd management plan should be developed as a matter of priority. A draft management plan which was prepared for the Bluenose caribou herds expired in 2004 without endorsement by all of the relevant management agencies.

In April 2009 the Advisory Committee for Cooperation on Wildlife Management approved the formation of a Working Group that would be responsible for preparing a draft management plan for the Cape-Bathurst, Bluenose-West and Bluenose-East caribou herds and their habitat.

Two rounds of community consultations were held and a final management plan was completed in May 2011. However this plan was not endorsed by all parties.

#### **Overview:**

At a meeting on August 31<sup>st</sup>, 2012 the Advisory Committee for Cooperation on Wildlife Management decided that the Working Group should be brought together to incorporate comments received on the management plan during the last round of consultations and to produce a new draft.



Following the meeting a technical writer was hired and the working group was contacted. After a conference call it was decided that the best course of action would be for both the Advisory Committee for Cooperation on Wildlife Management and the working group to have a face to face meeting.

The Advisory Committee for Cooperation on Wildlife Management met January 24-25, 2013 in Yellowknife to discuss revisions needed for the draft *Taking Care of Caribou: the Cape Bathurst, Bluenose-West, and Bluenose-East Barren Ground Caribou Herds Management Plan* (May 9, 2011) (the "**Draft Plan**"). As part of that process, the Members discussed at length the Inuvialuit Game Council's letter dated April 19, 2012 and the Wildlife Management Advisory Council (NWT)'s letter dated January 10, 2013. The Wildlife Management Advisory Council informed the Members of the Advisory Committee for Cooperation on Wildlife Management that they would not take part in further work to revise the Draft Plan until it has consulted the Inuvialuit communities on herd exchange and whether there is one or three Bluenose herds. The representatives from Wildlife Management Advisory Council left the meeting after the first day. The remaining members of the Advisory Committee for Cooperation on Wildlife Management continued to work towards the goal of completing another draft of the Management plan by June 30<sup>th</sup>, 2013 and decided to write a letter to Wildlife Management Advisory Council addressing their concerns (Appendix1).

The Advisory Committee for Cooperation on Wildlife Management and the working group will continue to work together through conference calls towards the common goal of completing the next draft of the management plan.

The next meeting will take place in Kugluktuk following the completion of the next draft of the management plan.

Re: Taking Care of Caribou: the Cape Bathurst, Bluenose-West, and Bluenose-East Barren Ground Caribou Herds Management Plan

Dear Mr. Carpenter and Mr. Pokiak;

The Wek'eezhi Renewable Resources Board (WRRB) has been asked to write this letter on behalf of the following Advisory Committee for Cooperation on Wildlife Management (ACCWM) Members: Gwich'in Renewable Resources Board (GRRB), Sahtu Renewable Resources Board (SRRB), Nunavut Wildlife Management Board (NWMB), Kitikmeot Regional Wildlife Board (KRWB), and the Tuktut Nogait National Park Management Board (TNNPMB).

The ACCWM met January 24-25, 2013 in Yellowknife to discuss revisions needed for the draft *Taking Care of Caribou: the Cape Bathurst, Bluenose-West, and Bluenose-East Barren Ground Caribou Herds Management Plan* (May 9, 2011) (the "**Draft Plan**"). As part of that process, the Members discussed at length the Inuvialuit Game Council's (IGC) letter dated April 19, 2012 and the Wildlife Management Advisory Council (NWT)'s (WMAC (NWT)) letter dated January 10, 2013. WMAC (NWT) informed the Members of the ACCWM that they would not take part in further work to revise the Draft Plan until it has consulted the Inuvialuit communities on herd exchange and whether there is one or three Bluenose herds. It is the hope of the ACCWM that common ground can be found while continuing to work on the Draft Plan with both organizations. Sustaining the herds will require the continued collaboration of all of the co-management bodies in the ACCWM. The ACCWM shares your concerns and recognizes that:

- the voice and relevant traditional knowledge of the affected communities must be incorporated in the Draft Plan;
- the issue of exchange of caribou between the herds, the population implications of such movements, and whether there are indeed one or three herds should be further discussed and analyzed in the Draft Plan;
- the reliability of pre-2000 survey data for all herds, including the Bluenose-East herd (issue raised by the IGC) should be addressed in the Draft Plan; and
- the issues that were brought up in community consultations should be addressed in the Draft Plan.

The ACCWM Members recognize the need to consult their respective communities and to incorporate both traditional and scientifick nowledge to achieve wildlife conservation. However, the GRRB, SRRB, NWMB, KRWB, TNNPMB and the WRRB believe that the interests of all communities will be best served by continuing to work on the Draft Plan — including further work on the issues raised above. The May 9, 2011 version of the Draft Plan was prepared on the understanding that a relatively short Management Plan was desired. Now it is understood that more detail is required. To this end, the ACCWM has directed the Working Group to:

- A. review their consultation notes to date and other sources of relevant existing information;
- B. revise the Draft Plan to address a range of issues, including 1-4 above; and
- C. complete its analysis by the end of June/13.

The Members also believe that the precautionary principle is the best approach for proceeding and that the distinction of the three herds is consistent with that approach, thus ensuring the long-term conservation of these herds. The distinction of the three herds was one of the fundamental bases for all of our organizations' work to date on the Draft Plan. If WMAC and IGC are now questioning the distinction of three herds, the ACCWM suggests that the consultations with Inuvialuit communities should focus on the following questions:

- Please describe your understanding of caribou movements on the landscape, including seasonal ranges (summer, fall, winter and spring), calving grounds, and migration routes.
- Based on the distinction of three Bluenose herds, how much exchange occurs between them? How often does the exchange occur? When and where does the exchange happen? Does exchange happen equally between the Cape Bathurst and Bluenose-West herds, the Cape Bathurst and Bluenose-East herds and the Bluenose-West and Bluenose-East herds?
- What are the advantages and disadvantages of managing on a one herd vs. a three herd basis?
- How can stewardship actions reflect both traditional and scientific perspectives equally and appropriately?

The timing of Inuvialuit consultations is up to WMAC (NWT). The Members would be happy to share the revised Draft Plan with WMAC (NWT) and IGC, as soon as it becomes available in late June 2013, if the up dated Draft Plan would be useful in WMAC (NWT)'s planned consultations. We thank the WMAC (NWT) for coming to our January 24, 2013 meeting and for explaining why and on what issues they must further consult Inuvialuit communities. We look forward to hearing from you.
